4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the 2023 Annual Monitoring Returns by Sensient Flavours Limited & Volac International Limited for activities at Felinfach Effluent Treatment Plant, Felinfach Industrial Estate, Lampeter, Ceredigion, SA48 8AG under permit number EPR/BP3135EB.

Monitoring returns and reports for the following period(s) have been assessed in this CAR form:

- 2023 Annual Returns: Emissions to Water (other than sewer)
- 2023 Q1 – Q4 Waste Returns
- 2023 Annual Performance Reports

This CAR was undertaken on 23 February 2024. However, to ensure that the CCS scoring is attributed to the correct financial year (for billing) the date on the CARS has been altered to 31 December 2023.

Compliance Assessment

Table S4.1 (Schedule 4(b)) of the permit states that the annual reporting period for emissions to water begins on the 1 January

Emissions to water (other than sewer) and land

The operator submitted the 2023 annual monitoring return on 31 January 2024 in the agreed reporting format (Form Water1).

The permit requires the operator to monitor the following parameters:

ELV exceedances reported for W1 Total phosphorous (Total P) on 28 July 2023 with a reading of 3.1 mg/l against a permit limit of 2 mg/l from a 24-hour composite sample. Felinfach ETP have been issued with a **Cat 3 non-compliance**, scored in line with CCS scoring guidance, for a breach of the emission limit values.

Permit condition 4.3.1 (b) states that – In the event of a breach of any permit condition the operator must immediately –

- i. Inform Natural Resources Wales, and
- ii. Take the measures necessary to ensure that compliance is restored within the shortest possible time

Permit condition 4.3.2 states that – Any information provided under condition 4.3.1 (a)(i), or 4.2.1 (b)(i) where the information relates to the breach of a limit specified in the permit, shall be confirmed by sending the information listed in schedule 5 to this permit within the time period specified in that schedule.

No Schedule 5 was submitted to NRW for the breach of the emission limits on the 28 July 2023, as outlined above. Felinfach ETP have therefore been issued with a **Cat 3 non-compliance**, scored in line with CCS scoring guidance, for a failure to notify NRW to a breach of emission limits set in the permit.

All other parameters recorded within permit limit values. No other non-compliances recorded.

Waste Returns

Quarterly waste returns have been submitted to NRW for all four quarters in 2023 using the specified reporting form (E-Waste and MF Return Form – NRW version 8). These returns are routinely emailed to NRW's Waste Returns Team and the regulating officer is copied in.

Waste codes consistent with Table S2.2 of the permit have been used within the 'Waste Received' portion of the returns, reflecting the industrial processes which direct effluent to the permitted installation. The total throughput of waste accepted at the site over 2023 does not exceed the annual limit outlined in table S2.2 of the permit.

The returns also include a record of waste(s) removed from the installation for recovery elsewhere (recovery code R10: land treatment resulting in benefit to agriculture or ecological improvement).

Annual Performance Reports

The following reports have been submitted to NRW in line with permit conditions, on 31 January 2024 in the agreed reporting formats (Form Performance1, Form WaterUsage1, Form Energy1). No issues noted.
