4. Details of our assessment

Forms Air1, Emissions to Air 2023; WaterUsage1 2023; Energy1 2023; Performance1 2023 and the Annual Review 2023 were all received on 6th February 2024. Corrected forms were received on 9th February 2024.

All the reports are accepted.

Air1, Emissions to Air 2023

All parameters were within their respective emission limit values (ELV), where applicable.

WaterUsage1 2023

Water usage was less than in 2022 but increased per tonne of production (ptp).

Energy1 2023

Total energy, electricity and NG burner fuel use all decreased in 2023. Total energy use was higher ptp, electricity use was lower ptp and NG burner fuel use was similar to that in 2022.

Performance1 2023

Production was almost 25% less in 2023.

Annual Review 2023

NOx emissions are controlled and within the ELV.

BOC are reminded that it is their responsibility to complete the reporting forms as directed on those forms and to ensure that Natural Resources Wales (NRW) receive these reports by the due date of 31st January each year. NRW may allow late reporting in exceptional circumstances, provided that they are informed in good time, prior to the submission date. It is not NRW's responsibility to remind operators that reports are due.

BOC have been issued with two actions to prevent future recurrence of late submission and to ensure that the initially submitted forms are completed fully with all the required information. Failure to complete these actions by the due date will incur at least one Cat3 non-compliance.
