#### **Morganite Annual Returns 2023**

This Compliance Assessment Report (CAR) has been issued in response to the submission of the 2023 Annual Monitoring Returns by Morganite Electrical Carbon Limited for activities at Electrical Carbon Swansea, Upper Fforest Way, Morriston, Swansea, SA6 8PP under permit number EPR/VP3339PD.

Monitoring returns and reports for the following period(s) have been assessed in this CAR form:

- Emissions to Air
- Waste Disposal and/or Recovery
- Water Usage
- Energy Usage
- Performance Indicators for the year

This CAR was undertaken on 22 February 2024. However, to ensure that the CCS scoring is attributed to the correct financial year (for billing) the date on the CARS has been altered to 31 December 2023.

#### **Compliance Assessment**

Schedule 4.2.2 of the permit states that the reports on the performance of the activities shall be submitted to NRW by the 31 January. The operator submitted the annual reports on the 15 February 2024. NRW may allow late reporting in exceptional circumstances, provided that they are informed in good time, prior to submission date. Morganite have been issued with a **Cat 4 non-compliance** for failure to submit the reports by the due date.
