**4. Details of our assessment****Western Bio Energy Limited**

Western Bio Energy (WBE) operates Western Wood Energy Plant in Margam in accordance to EPR/ZP3939GL/V006

The WBE Plant is a co-incineration power plant for the generation of electrical power by the combustion of biomass fuel. Plant has capacity for burning approximately 160,000 tonnes of biomass per annum, providing 14MW of electrical power supplied to the national grid. The plant has capacity to consume both virgin wood material and waste wood biomass.

**Purpose of Compliance Assessment**

The following monitoring returns and report have been assessed within this Compliance Assessment Report (CAR):

- Quarter 4 (Q4) October to December 2023 Continuous Monitoring Returns, Emissions to Air.
- Biannual 2 July to December 2023 Periodic Monitoring Returns
- Quarter 4 (Q4) October to December Residue Quality

**Compliance Assessment****Q4 2023 Continuous Monitoring Returns**

The operator submitted Q4 2023 monitoring returns via email on 25<sup>th</sup> January 2024, this falls within the specified reporting window. Compliant with permit condition (4.2.3). All Continuously monitored parameters stated in the permit (S3.1) have been assessed. Reported results are in compliance with the associated emission limits.

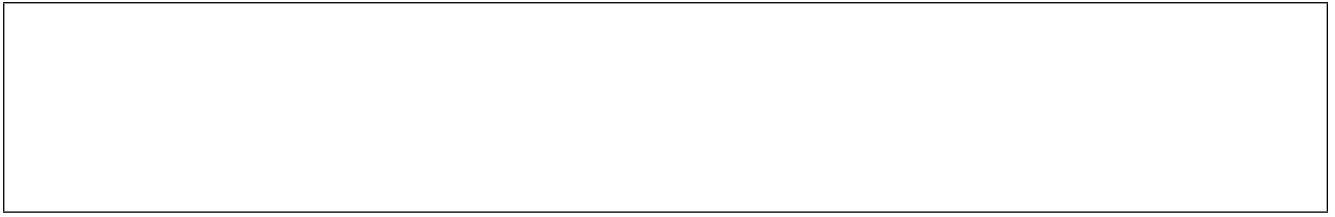
**Biannual 2 July to December 2023 Periodic Monitoring Returns**

Periodic monitoring was not undertaken during Biannual 2 period (July to December). Plant breakdown and availability of monitoring contractors prevented testing. Sampling now agreed to be undertaken in February, deemed the soonest availability for the monitoring contractors. Sampling has now been agreed to be carried out on three occasions during 2024. (Discussed via email on 29<sup>th</sup> January 2024).

Operator failed to notify NRW that monitoring would not be undertaken at the required frequency. It is a requirement of the permit, condition 4.3.1(b), to notify NRW via a schedule 5 when monitoring is unable to take place. In accordance with non-compliance scoring guidelines a non-compliance score of C4 has been allocated against sub-criteria IR4C Notification.

**Q4 October to December Residue Quality**

Bottom and Fly Ash analysis has been undertaken. Reported results comply with the monitoring of all parameters stated in Table S3.5.
