1. SOURCE OF SUPPLY

Inland water, an unnamed tributary of the Nant Cadlan, at Penderyn, Merthyr Tydfil.

2. POINT OF ABSTRACTION

At National Grid Reference SN 9521 0917 at the point marked "A" on the map.

3. MEANS OF ABSTRACTION

A pump of maximum output not exceeding 1.27 litres per second.

4. PURPOSE OF ABSTRACTION

Industrial – manufacture of premix concrete.

5. LAND ON WHICH LICENCE AUTHORISES USE OF WATER

The area of land known as Penderyn Quarry.

6. PERIOD OF ABSTRACTION

All year.

7. MAXIMUM QUANTITY OF WATER TO BE ABSTRACTED DURING THE SPECIFIED PERIOD

4.546 cubic metres per hour.

45.46 cubic metres per day.

10,911 cubic metres per year.

N.B. An hour means any period of 60 consecutive minutes, a day means any period of 24 consecutive hours and a year means any period of 12 consecutive months.

8. MEANS OF MEASUREMENT OF WATER ABSTRACTED

The licence holder shall provide and maintain to the satisfaction of the Agency a meter, structure or other device as may be directed or approved by the Agency for measuring or assessing the quantities of water abstracted.

9. RECORDS

The licence holder shall take and record readings of the meter, structure or device as specified in condition 8 at the same time each month.

A copy of the record or summary data from it shall be sent to the Agency in a form prescribed or approved by the Agency.

Each record shall be kept and made available during all available hours for inspection by the Agency.
