2023 Annual Submission

The aforementioned forms were submitted by the Operator on the 22nd of January 2024, these forms details informative requirements (Schedule 4: Tables S4.2 and S4.3) which were set out by NRW within permit condition 4.2.2.

The information was submitted within the agreed reporting period (31 days), included all the required information and utilised the forms specified by NRW. As a result, the Operator is **compliant** with permit condition 4.2.2a, 4.2.2b and 4.2.2c.

Within their submission, the Operator also included reported maximum figures regarding Emissions to Air and Water (Other than Sewer). While this is a good indicator of environmental performance over the year, it is not a requirement of their annual reporting obligation (permit condition 4.2.2) and the contained figures have already been discussed within previous Quarterly CAR forms. As a result, these will not be assigned a non-compliance score within this CAR.
