Notification of first exceedance

The discharge shall not contain more than 18 milligrams per litre for BOD. The sample taken on the 15 January 2024 produced a reading of 26 mg/l.

This is the 1st exceedance for BOD at this site within the last 12-month period. Based on the LUT and the sites sample frequency, this result is classed as an LUT exceedance. Please provide an explanation for the exceedance by the 28 March 2024. Please provide the information to
