Emergency venting x22 occasions with RTO on bypass. Compared with 20 the previous year.

Process vents reported 0 releases in 2023 compared with 2 in 2022.

No bund breaches. No accidental spills. Envirovalves upgraded in 2023.

Hazardous solid waste returned to bag handling for 4 months due to processing difficulties, original process reinstated after this and waste stream eliminated.
