4. Details of our assessment

The main purpose of the Runtech Limited (Runtech) activities at the Port Talbot installation are to serve the Tata Steel UK Limited (TSUK) steelworks processes (EPR/ BL7108IM). These activities are directly associated with steel production and include scarfing of steel slabs.

Purpose of Compliance Assessment

The operator submitted the Q4 2023 monitoring returns on the 26th January 2024, which is within the specified reporting window, representing compliance with the permit condition (4.2.3).

AS1 - Scarfing Air Filtration Plant

The continuous PM results for the monitoring period have been submitted no exceedances of the 10 mg/m³ hourly average emission limit recorded.
