SIMEC have requested permission to receive a small quantity of waste material onto site for the purpose of conducting milling trials of a proposed new fuel for the facility. This fuel is a waste energy pellet prepared from segregated waste plastics and paper/cardboard. It will be supplied to SIMEC under EWC Code 191210.

Condition 2.3.7 of the permit does not allow the importation of waste unless this is listed in Schedule 2 of the permit. There are no waste exemptions that could be used for this purpose.

On the basis that; SIMEC will ultimately need to submit a variation application for the conversion of the coal fired power station to an energy pellet (currently classified as waste), the proposed milling trials are short term, a plan has been submitted to NRW (Email received 09/07/2019), then NRW gives permission for the trials to be undertaken subject to the following requirements:

- The trials are conducted in accordance with the plan provided
- NRW is notified of commencement of the trials and completion of the trials
- NRW is provided with a summary report of the trials following completion.

There are no changes to any permit conditions as a result of this CAR form.
