### 4. Details of our assessment

A routine site inspection was undertaken on Tuesday 20th February 2024. Present at the time of the inspection were: David Morgan (Natural Resources Wales) and Tony Davies (TD Tyre Recycling Ltd).

An inspection of the site was undertaken and the following observations were made:

#### **Waste Storage**

Generally, the volume of waste tyres on site has been reduced since previous inspections. At the time of the inspection on 20th February 2024, tyres were stacked no more than 2/3 in height, however, there was insufficient spacing to create firebreaks.

Waste tyres were mostly stored in one stack without firebreaks as is required in your Fire Prevention and Mitigation Plan. As a result, a non-compliance with your Environmental Permit has been recorded. It should be noted that although not compliant, the non-compliance is recorded as **minor** as waste tyres were stored within the height limits and in the event of an incident, it is assumed waste stacks could be split and firebreaks implemented with ease.

#### **A non-compliance was recorded against Condition 3.6.1 of your Environmental Permit (Category 3 - Minor)(Ref:C4)**

You must ensure all waste is stored in line with the parameters set out in your Fire Prevention and Mitigation Plan.

#### **Notable Observations**

Site security appeared to be well maintained with secure fencing and CCTV system in use.

Site infrastructure appeared to be of a sufficient standard with waste being stored on hardstanding or an impermeable surface.

Waste types and treatment processes appeared to be compliant as listed in the

Environmental Permit.

Activities did not appear to be having a detrimental impact on the local amenity (e.g. no dust/waste escaping site).

### **Management Systems and Documentation**

A copy of the Environmental Permit was displayed on the wall of the office at the time of the inspection. Copies of the Environment Management System (EMS) and Fire Prevention and Mitigation Plan (FPMP) are kept on site but were not readily available at the time of the inspection.

As discussed on site, please ensure copies of these documents are made available on site and staff know where/how (if stored digitally) to locate them. In the event of an incident or accident, staff may be able to better assist with a response if these documents can be located easily.

### **Summary**

A site inspection was undertaken on Tuesday 20th February 2024. Operations were largely compliant although waste was not being stored in strict compliance with the requirements of the Fire Prevention and Mitigation Plan. This was recorded as a minor non-compliance.

It was agreed that firebreaks would be reinstalled and photographs confirming this would be sent to Natural Resources Wales confirming this action had been completed. Please complete this action by **Thursday 7th March 2024**.

Please ensure all relevant permits and management systems are available for all staff on site as they may be able to assist with the response in the event of an incident.
