4. Details of our assessment

On the 23rd August 2022, we received a notification that the regular bacterial sampling of the designated bathing water at Wiseman's Bridge beach (SN 14688 06090) had returned results that

showed that the waters here exceeded bathing water limits.

This site was attended by Chris Roscoe, Environment Officer on the same day for further investigation, and to identify any sources of pollution. As part of this investigation, the discharge point of the Package treatment plant, UV disinfection and aerated reed bed system serving Wisemans Bridge Inn was found to be discharging turbid water, that contained foam and had with it a sewage odour. As this discharge is known to release a clear, odourless discharge, this indicated an issue with the treatment process.

Contact was then made with Rhys Kemble, who identified himself as your son, and arranged the repair of the equipment.

Samples were taken on the day, and our laboratory analysis shows that the discharge at the time had a chemical composition that exceeded the limits for ammonia and suspended solids, as set out in the permit EPR/VB3093HD.

The failure to correctly treat the sewage material has led to breach of permit condition. This non-compliance report is issued with regards to the damage caused to the environment due to the pollution incident.

NRW requires you to take the following actions to avoid further damage to environment.

- Improve the infrastructure - repair assets and operations on site
- Update your regular monitoring plan to increase the frequency of equipment checks to avoid future problems
- Comply with permit conditions
