4. Details of our assessment

Condition 4.2.2 of the environmental permit states:

A report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January (or other date agreed in writing by Natural Resources Wales) each year. The report(s) shall include as a minimum:

- (a) a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data;
- (b) the annual production/treatment data set out in schedule 4 table S4.2; and
- (c) the performance parameters set out in schedule 4 table S4.3 using the forms specified in table S4.4 of that schedule.

Condition 4.2.3 of the environmental permit states:

Within 28 days of the end of the reporting period the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:

- (a) in respect of the parameters and emission points specified in schedule 4 table S4.1;
- (b) for the reporting periods specified in schedule 4 table S4.1 and using the forms specified in schedule 4 table S4.4 ; and
- (c) giving the information from such results and assessments as may be required by the forms specified in those tables.

The monitoring report(s) submitted do not include an interpretive review and assessment as required by condition 4.2.2 (a) which represents non-compliance the environmental permit.

Condition 4.2.2 has been breached as the reports were submitted late.

The late submission of reports has been scored a C4 (no environmental impact) non-compliance based on it not foreseeably having any impact on the environment, people and/or property due to report/s being received after the due date but containing all the required information (except interpretative review, scored below).

Due to the no environmental impact of the late submission this aspect of the permit breach has not been allocated an action.

Condition 4.2.2 (a) has been breached as no interpretive review of the data has been provided.

The non-submission of the interpretive review has been scored a C4 (no environmental impact) non-compliance based on it not foreseeably having any impact on the environment, people and/or property due to no known potential impact

for not completing the review.

ACTION: Interpretive review. Operator to submit to NRW an interpretative review as required by permit condition 4.2.2 (a).

The non-submission of the interpretive review has been scored a C4 (no environmental impact) non-compliance based on it not foreseeably having any impact on the environment, people and/or property due to report/s being received after the due date but containing all the required information.

Due to the no environmental impact of the late submission this aspect of the permit breach has not been allocated an action.

The report(s) submitted are for the reporting periods specified in schedule 4 table S4.1 which represents compliance with the environmental permit.

The report(s) have been submitted using the forms specified in schedule 4 table S4.4 which represents compliance with the environmental permit.

The monitoring report(s) submitted include results and assessments as required by condition 4.2.3, schedule 4 table S4.1 and S4.4, which represents compliance with the environmental permit.

Reported emissions to air for the period from 01/01/2023 to 31/12/2023 for emission points A1, A2, A3, A4, A5, A7 and A8 were all within permitted limits given in schedule 3b, table S3.1 in respect of the maximum value obtained during the reporting period which represents compliance with the environmental permit. NB emission point A6 not installed and associated process not yet operational.

Reported emissions to sewer, for the period from 01/01/2023 to 31/12/2023 for emission point S1 were all within permitted limits given in schedule 3b, table S3.3 in respect of the maximum value obtained during the reporting period which represents compliance with the environmental permit.

Reported results of ambient air monitoring for the period from 01/01/2023 to 31/12/2023 were all within permitted limited given in schedule 3b, table S3.4 in that no limits apply to this monitoring which represents compliance with the environmental permit.

There were no reported emissions to W1 for the period from 01/01/2023 to 31/12/2023 which represents compliance with the environmental permit. *The operator does not emit*

anything from W1 to controlled waters despite having the release point in the permit; all surface and rainwater collected is treated and reused on site.

NB date of assessment is set at 31 December 2023 for NRW financial recording reasons.
