4. Details of our assessment

Monitoring sample taken 08/02/24. Suspended solids result of 90mg/l. Permit limit 30mg/l.

Had a phone call discussion with Chris to see what had been done in regards to the failure. He said a drainage survey had been done to identify surface water inputs, none identified besides what flows through the covers of the PTP.

Chris mentioned Drainforce had been over to conduct a service of the PTP and mentioned they will replace the media as they mentioned this should be done every 5 years which had not taken place. They mentioned to him they are confident this will improve the suspended

solids results once the bacteria has established on the new media.
