4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the 2023 Annual Monitoring Returns by GP Biotec Ltd for activities at Great Porthamel Anaerobic Digestion Plant, Talgarth, Brecon, Powys, LD3 0DL under permit number EPR/AB3233DDW.

Submission of the monitoring returns and reports have been assessed in this CAR form:

- Reporting of emissions to air for the year 2023
- Reporting of emissions to water (other than sewer) and land for the year 2023
- Performance Indicators for the year 2023

This CAR was undertaken on 29 February 2024. However, to ensure that the CCS scoring is attributed to the correct financial year (for billing) the date on the CARS has been altered to 31 December 2023.

Compliance Assessment

Schedule 4.2.2 of the permit states that the reports on the performance of the activities shall be submitted to NRW by the 31 January. Schedule 4.2.3 of the permit states that the parameters outlined in table S4.1 shall be reported to NRW within 28 days of the end of the reporting period. The operator submitted the annual reports on the 23 February 2024. NRW may allow late reporting in exceptional circumstances, provided that they are informed in good time, prior to submission date. GP Biotec have been issued with a **Cat 4 non-compliance** for failure to submit the annual reporting by the due date.

A full review of the 2023 annual returns submitted by GP Biotec will be conducted in due course.
