### 4. Details of our assessment

Natural Resources Wales senior industry and waste regulation officers Carter Shone and James Mcclymont visited Toyota on the 19<sup>th</sup> February. This was a pre-arranged familiarisation visit and site inspection accompanied by the Senior Manager - Maintenance and Technical Support, Section Manager- Facilities, Section Manager - Casting Engineering and the Principal Engineer.

At the time of the inspection the site was operational.

Weather conditions cold but clear day.

#### **Permitted activity**

NRW officers were given a full tour of the casting facility. The area was extremely clean and organised.

The emission points for the activities were clearly designated with information available for all personnel, with a copy of the permit clearly marked and available.

All emission points were well maintained.

NRW officers were informed of any future changes.

#### **Emissions to water, air or land**

NRW officers were shown the penstock system for controlling surface water from the site. The system was well maintained and the operating procedures for its release were well documented and thorough.

The water treatment system despite its age was extremely well run with very clear procedures and contingencies in place.

#### **Odour**

No offsite odours were noted during the inspection.

#### **Noise**

Offsite noise was not deemed to be at all excessive

#### **The site**

NRW officers were given a full tour of the entire site.

The officers were shown the plants nature reserve that has been completed over the last year using recycled materials. Which include a pond and beehives, increasing the biodiversity of the local environment by 400%.

The site also allows and encourages college and university groups to use the reserve for study and education.

The officers felt this went above and beyond demonstrating a commitment to sustainability.
