### 4. Details of our assessment

Site inspection was conducted on the 09/01/2024 Llyr Samuel, Rachel Mallinson and Thomas Anthony, to assess the sites security and that it remains non-operational.

During the inspection, the following observations were made:

The site is no longer operated as J&A Metals, but rather Pendragon Waste & Skip Hire under a new permit

(permit ID: XP3097EG).

J&A Metals has been non operational since 2011 and remains non operational but the permit is still active

I would suggest that the permit holder should contact NRW to discuss the permit.
