Unannounced site inspection undertaken by Rachel Mallinson, Llyr Samuel and Thomas Anthony, to assess the sites security and that it remains non-operational.

During the inspection, the following observations were made:

Site was clearly non-operational.

**No waste activities were observed.**

**The site did not contain waste.**

**The site had barrels blocking the site entrance to prevent vehicle access however the site was not fully secure.**
