**4. Details of our assessment**

On 22nd February 2024 Angharad Clark carried out a routine site inspection at Rees Metals. the weather was very wet with flood warnings in place for SW Wales. On arrival at the site it was noted that there were three skips of waste stored on the parking areas outside the permitted area. Mr Jones stated that he would bring the skips into the permitted area that evening. The site was very full. The trommel has not been in use for the past 18 months. They are using an attachment on the grab machine to cut metal instead. Despite the very wet weather, the site was not flooded and all areas were accessible. Sharon Davies in the office enquired whether invoices were sent out prior to subsistence fees being charges. I have asked out permitting department to include Sharon's email address ([sharondavies152@yahoo.com](mailto:sharondavies152@yahoo.com)) in the invoice process.
