3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

An unannounced inspection was carried out on the 23 February 2024. There were heavy showers on the day of the visit.

C4 general management – storage, handling, labelling and segregation

The ELV treatment building was full and inaccessible for the treatment of ELVs. This area must be kept clear for the storage of non-depolluted vehicles, to carry out the depollution activity and to store liquids from the depollution activity. Again, tyres were being stored in this building. Tyres must be stored in the shipping container in area A6 as shown in the Environmental Management System.

The volume of ferrous metal waste appeared to be reduced since the last inspection but the height of the ELVs being stored appeared to be too high (approximately 6 stacked vehicles). Because of the way ELVs were being stored, they were impossible to inspect to ensure they had been fully depolluted.

This is a Category 3 breach of Condition 2.3.1(a) – the activities shall, subject to the conditions of this permit, be operated using the techniques and in the manner described in the documentation specified in schedule 1 table S1.2 (EMS & FPMP)

Action: clear the ELV treatment building to enable effective treatment of ELVs

Waste carrier registration

The operator has registered as an upper tier waste carrier/broker/dealer (ref:CBDU10435) which expires on the 3 June 2026

Waste returns

Waste returns have been submitted and are up to date

Hazardous Waste Producer

The operator has registered the site as a hazardous waste producer (ref: CAB036) which expires on 21 July 2024

E2 Emissions – Land and groundwater

We have received sample results for spring Well 1 and Spring Well 2 (ref. P23-034). Unfortunately, the samples have been tested for a private water supply. Please can you test the subsequent samples for the required parameters listed on page 4 of the Emissions Monitoring Plan – Groundwater. Sampling and testing of both springs should be carried out two times a year.

Action: Please provide the sampling results for Spring Well 1 and Spring Well 2

A1 Specified by permit

Category 3 breach of condition 2.2.1

Waste was being stored outside the permitted boundary. This is a category 3 breach of

condition 2.2.1 – *The activities shall not extend beyond the site.*

Action: Remove waste deposited outside permitted boundary
