4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards and Richard Samuel of Natural Resources Wales accompanied on site by TCM Darren Hemming.

Upon arrival officers completed the site induction as requested by the operator.

General (C1, C2, C3)

During the inspection of the waste storage areas officers noted good separation of wastes in the skips. No non-compliant wastes were identified during the inspection in line with **condition 1.2.1** of the permit.

Officers requested copies of permit and working plan for the site, both documents were provided as required under **condition 1.3.2** with the working plan being kept a live document and annually reviewed. Darren Hemming was able to demonstrate the knowledge and understanding of the permit and working plan as required under **condition 1.3.3**.

Site engineering and infrastructure (B1)

All wastes were stored on an area of impermeable surface as required under **condition 2.1.1** with the surface being in a state of good repair and no defects identified at the time of the inspection.

Waste storage (B4, C4)

All wastes were stored appropriately within clearly labelled skips, tanks or containers as required under **condition 4.6.1** and **table 4.6**. LPG gas cylinders were all stored within a secured cage as required under the above condition.

Amenity management and reporting (F3, F5)

No debris was identified on the highways entering the site as required under **condition 4.1.1**.

Officers noted that the site was kept in good condition with no litter identified within or directly outside the site as required under **condition 6.5.1**.
