4. Details of our assessment

Site Report

On Friday 1st December 2023 I visited RSPB Visitors Centre, Nash Road, Nash, Newport NP18 2BZ to carry out a permit inspection on their Sewage Treatment Plant. Permit Number AN0403501. I arrived on site at 11.00. The weather conditions were sunny, frosty and cold. My Site inspection commenced at 11.10.

Observations

I proceeded to identify the location of the Package Treatment Plant. Please see Photo 1 below.

Package Treatment Plant (Photo 1)



I lifted the lid on the first/second chamber and identified a large amount of solid waste within the chamber. This is expected as it is the primary chamber. A slight odour was present. Please see Photo 2 below.

First/Second Chamber (Photo 2)



I lifted the lid on the third/fourth chamber and could see that the amount of solid waste had greatly reduced. There was still a slight odour present. The Bio-media within this chamber was functioning as designed reducing the amount of solid carry over. Please see Photo 3 below.

At this point I had a discussion with Steve Jones with regards to the operation of the Sewage Treatment Plant. I asked Mr Jones if that had been any incidents, malfunctions or breakdowns. Mr Jones advised that there has been no issues with the Sewage Treatment Plant. I took some general photos of the Sewage Treatment Plant. Please see Photos 4 and 5 below.

I proceeded to check the sample point location at NGR ST 33480 83280. I confirmed this to be accurate as stipulated by the permit. The water was clear with no odours present. Please see Photo 6 below.

I then proceeded to check the discharge point at NGR ST 33585 83194. Discharge to Greathouse Reen. I confirmed the discharge point was accurate as stipulated by the permit. The discharge was clear with no odours present. Please see Photo 8 below.

I had a discussion with Mr Jones with regards to maintenance logs and relevant paperwork regarding the Sewage Treatment Plant Permit. Mr Jones advised all paperwork would be emailed to myself.

I left site at 11.45.

The above actions are required by the 23rd April 2024.

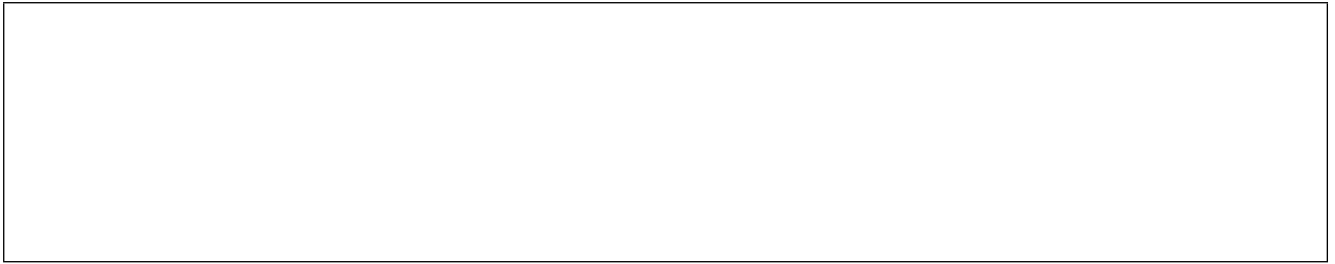
