### 4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards and Richard Samuel of Natural Resources Wales accompanied on site by operator Mark Adams.

#### **General Management (C1 & C2)**

During the inspection it was noted the site operates in line with the current working plan as required under **condition 1.1.1**.

Officers were provided copies of the permit and the working plan on request in the office as required under **condition 1.1.3**.

#### **Waste Acceptance and Storage (B4, C3 & C4)**

Activities on sites were in accordance with **condition 2.1.1** and limits specified in **schedule 1 table S1.1** of the permit with members of the public being directed to appropriate waste skips and storage areas.

All wastes were stored within skips or bins on suitable surfaces and within the permitted area as required under **condition 2.2.1**.

Wastes identified during the inspection conformed to the types listed in **schedule 2, tables S2.1 and S2.2** as required under **condition 2.3.2 (a)**.

#### **Emissions (F1 & F2)**

The site activities did not give rise to any noise or odours likely to cause pollution at the time of the inspection as required under **conditions 3.2.1 and 3.3.1**.

#### **Miscellaneous (F3 & G2)**

The daily inspections record was completed by the operators and reviewed. Some litter was identified on site but the operator confirmed that as part of the routine operations, these would be collected at the close of day.

Discussions were held on site with the potential for litter to enter the nearby school through the rear fence, officers suggested installing a smaller mesh fence or net to ensure that no litter escapes site.
