4. Details of our assessment

The Bryn Posteg Landfill Site and its suite of various permits were inspected by the regulating Natural Resources Wales (NRW) officers Paul Challender and Jamie Blythin. The NRW officers were accompanied by the Site Manager and the Environmental Technician.

The Gas Utilisation Plant (GUP) is a Directly Associated Activity (DAA) to the landfill site environmental permit and is operated under under its own standalone environmental permit RP3338TA .

The GUP compound was viewed externally from the palisade fence and discussions took place between the NRW officers and the Site Manager. One of the gas engines had been removed as expected and the installation was stated to to imminent and scheduled to take place during the week commencing 26/02/24.

NRW has not received notification that this installation has occurred.

Action: Notify NRW when the replacement gas engine is installed and commissioned.
