4. Details of our assessment

Incident response on 23/01/2024 after a report of the WWTW discharging effluent. Officers Emily Roe and Callum Murray attended and substantiated the report to land only.

Located adjacent to a SSSI. During the site visit, a very small amount of diluted effluent was seen surcharging through the tank cover.

DCWW investigated and found a collapse sewer which was subsequently repaired. Site was demobbed on 31/1/24. Discharge contained to land only.

Categorised as a C3 - 'A non-compliance which could have a minor environmental effect' due to the possible potential impact.

No impact claim accepted due to evidence provided - no pollution to the watercourse.

Actions:-

- Ensure WWTW is in good working order
- Ensure site is regularly monitored
