4. Details of our assessment

This was a pre-planned audit carried out by Natural Resources Wales environment officers who were accompanied by a senior operative and performance manager from Dwr Cymru.

The weather was dry with rain experienced in the days leading up to the visit.

General Observations

Officers inspected the overflow at the inlet at Golden Grove WWTW. The discharge point into the tributary of the was expected by officers later in the day, however the pipe was not visible from the road due to the

marshy nature of the field, but the receiving watercourse was not visibly polluted, with no fungus or odour present.

The Process

The storm discharge comes from the inlet of the Golden Grove WWTW, this site has a separate discharge permit (BJ0078801) and this is covered by a separate CAR form. The storm discharge is screened by a sac, and this is emptied roughly every month. There is an EDM monitor on the inlet that records when the storm overflow is operating.

The asset spilled 91 times in 2022 this seems to be quite high.
