4. Details of our assessment

On the 18 March 2024 an unannounced site inspection was undertaken at A J Recycling Limited permit number EPR/JP3998FN. David Ellar (NRW) was accompanied around the site by Sonia Jenkins (AJ Recycling).

The weather was fine and dry.

Permit breaches identified:

No permit breaches were observed during this visit.

Previous inspections:

A Category 4 permit was recorded during our previous visit on the 22 February 2023 (CAR_NRW0041578). A minor issue was observed where quarantine waste was not being stored in accordance with condition 4.4.2 of the permit. This issue was quickly resolved by the operator.

During this visit there was no quarantined waste on site, the quarantine skip was empty.

General Observations:

The site was generally very clean and tidy and good segregation of waste types was observed.

The drainage system was checked and appeared clear of debris.

Evidence of TCM Continuing Competence for Sonia Jenkins was presented. Sonia Jenkins CC expires 20/12/2025.

Sonia Jenkins confirmed that the site had de-notified as a materials facility due to changes in operation.
