Request for abatement of fees

As you are aware, NRW raise invoices against operators for permit subsistence charges through our annual billing process. This charge covers our costs for regulating the activity an operator undertakes.

If an operator queries an aspect of a charge we have billed, this debt is marked as being in dispute and referred to the business to be resolved.

As per our [Environmental Permitting Charging Scheme 2023-24](#) NRW may, by notice to the operator, waive or reduce any charge specified in this Scheme if it considers it to be significantly disproportionate in a particular case.

You have queried your charge and asked for your subsistence fees to be abated/reduced because activities included in your environmental permit are no longer happening.

An abatement to an operators invoiced amount can only be agreed in particular cases, based upon actual costs and expenses incurred, or to be incurred, by NRW.

We have reviewed your query and request to abate your fees. Apologies for the length of time this process has taken.

When we assess an operators request for an abatement, we must pay regard to an operator's compliance history. This is because of the costs and expenses incurred in the regulatory effort required to address any non-compliance.

We won't abate fees where an operator has a history of failing to address non-compliance because the operator's fees cannot be considered significantly disproportionate to the charges within the above Scheme, for the above reason.

As you are aware, since 2017 NRW have identified non-compliances for the storage of waste at your site. These non-compliances were still occurring at our inspection on 1st Nov 2023.

Therefore, NRW will not abate your subsistence fees for the above reasons and we cannot re-review this billing query or abatement request until compliance with the permit has been achieved.

A further CAR form will cover the actual physical site inspection in due course.
