### 4. Details of our assessment

**Site Report**

On Friday 16th February 2024 I visited Tesco Distribution Centre, Westway, Europark, Caldicot NP26 3TS to carry out a permit inspection on their Trade Effluent Site Drainage. Permit Number AN0393103. I arrived on site at 9.24. The weather conditions were sunny and cold. My Site inspection commenced at 9.30.

### **Observations**

I proceeded to check the sample point as stipulated by the permit at National Grid Reference ST 40265 86120. (I could not establish the sample point at this location)

I proceeded to check the discharge point as stipulated by the permit at National Grid Reference ST 40272 86117. (I could not establish the discharge point at this location)

I had a discussion with the security guard on site and asked who I would need to speak to with regards to the Trade Effluent Site Drainage Permit. The security guard advised Terry Hooper would be the person required. Mr Hooper was not on site the day of my visit.

### **Action required by date specified:**

- Waste transfer notes and maintenance logs need to be submitted.
- A detailed site plan identifying both the sample point location and discharge point location needs to be submitted. (Please include photographs and NGR's)
