4. Details of our assessment

Introduction

This report details the site visit made on the 6 March 2024 to AP Waters Building Contractors Limited, Permit number EPR-AB3898HB. Officer Carla CURTIS arrived at site around 12:30 for an unannounced inspection, the weather conditions were mild and sunny at the time of inspection.

General Observations

The site was fully operational and busy at the time of the visit, with no visible waste being stored outside of the permit boundary. There were no apparent issues with site infrastructure.

Waste Activities

Waste activities on site at the time of inspection consisted of treatment of construction and demolition waste. The operator treats this using a screening bucket to separate the different sized waste.

Drainage System

No issues with drainage or condition of the impermeable surface at the time of the inspection. The yard benefits from a fully sealed drainage system which has both a silt settlement pit and oil interceptor, both of which are regularly maintained.

Technical Competency

The allocated Technically Competent Manager (TCM) for the site is Gareth Hill, certificate expires May 2024.

Waste Return Submissions

These appear to be up to date and correct. The latest waste return for Q4 2023/24 was received on 30/01/24. Waste codes accepted: 200301, 170302, 170201, 170107 & 170802 totalling 380.87 tonnes. 46.78 tonnes were removed from the site as waste, coded as 170904 & 170802, 200138, 170402, 200301 & 191202. Please continue to submit quarterly waste returns within one month of the end of each quarter, in line with your permit.

Permit compliance and breaches - No permit non-compliances were identified on this visit and thus no breaches have been scored.
