4. Details of our assessment

Environment officers from the Pembrokeshire ET met with operatives from DCWW on site. The site is susceptible to water infiltration issues that are attributed to the age of the works and need for possible investment. The investment in question may include the installation of a new sludge holding tank as part of the next business plan. A return was planned to inspect the receiving watercourse due to the presence of rags/sanitary products seen on the floor of the treatment works. **The return visit found there to be sanitary products and sewage fungus within the watercourse up to 15m downstream. This would suggest persist discharge from the storm outfall to allow for growth of fungus overtime.**

Furthermore, the permitted PFF is 0.99 l/s and there are concerns within the ET team that this may be an indicator that this site is regularly discharging as a result of the lower than expected PFF which may be compounded by the infiltration issues. A new phosphorus limit variation was noted as recently being set at 5mg/L.

The DCWW EDM team are to inform the Pembs ET of how often this site spills. The site is visited three times a week (Monday/Wednesday/Friday). Sludge is routinely removed once per week but this can vary depending on factors such as time of year, flows, compliance and loading of site.
