4. Details of our assessment

Site report

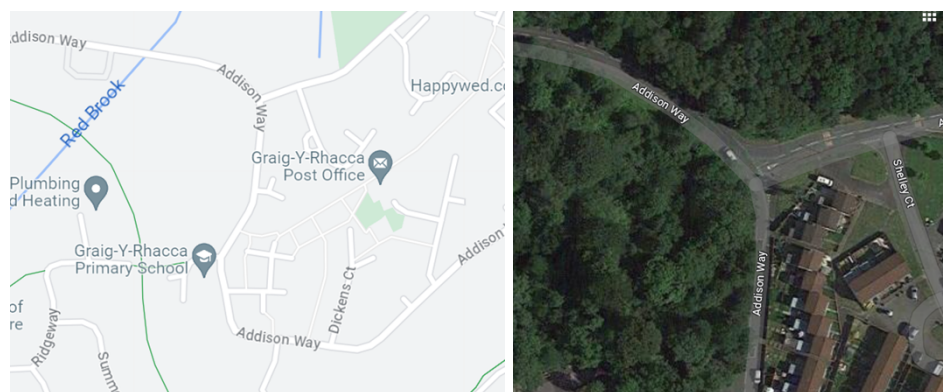


Fig 2. Location of surface discharge point.

I (Megan Jones; Environment Officer) conducted preliminary investigative research prior to my inspection of permit number AE2037501; surface water discharge from housing estate into Red Brook and into the River Rhymney in Graig-Y-Rhacca. As this is a surface water only discharge (Fig 1 and 2), a water discharge permit is not required. Upon discussion with a representative from Dwr Cymru, it was confirmed that Dwr Cymru have ownership of

the surface water lines.
