Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

For clarity, this CAR has been completed on the 19th December 2023 but refers to the spills that occurred from the emergency overflow on the 30th October 2023.

An OPNOT, followed by a WATPOL (self report) was submitted by DCWW to NRW on the 30th October 2023. Operators attended the site and found to wet well to be at high level and spilling from the emergency overflow. The pump that was running was not pumping anything. Upon discovery, the pump duty was switched to the second pump.

An update stated that "flows have now been pumped down to normal levels and the asset is no longer spilling but operators are staying on site to check over site".

Discharge of sewage in emergency via Outlet 1 An emergency shall be defined as the period when the sewage pumping station is inoperative as a result of one or more of the following, which is not due to the act or default of the operator, its agents, representatives, officers, employees or servants; • electrical power failure; • mechanical breakdown of duty and standby pumps; • rising main failure; • blockage of the downstream sewer.

NRW suggests that a warning system should be put in place to detect when there is no flow through pumps to prevent non-emergency spills occurring via the emergency outfall.
