4. Details of our assessment

This was a pre-arranged site handover inspection from the previous regulating officer, Phillip Harper to the current regulating officer, Kathryn Bradshaw.

The General Manager for the site accompanied us on a site tour. We viewed the effluent treatment plant area where work is ongoing to improve site containment. The online readings of pH, turbidity and temperature was checked and all were in compliance with the emission limits. The auto sampler was checked, the collection container and sampler itself were clean and functioning correctly. A sample of the treated effluent was taken to demonstrate the quality of the treated effluent. The new above ground tank has been piped in and linked to the scrubber system but is not currently in use as this is part of the ongoing permit variation.

The borehole for the site was viewed which is metered and contained within a building. Sodium hydroxide is dosed into the extracted bore hole water and stored in an adjacent tank for use inside the factory. The sodium hydroxide containers were all stored in secondary containment inside the building. The ammonia plant and scrubber system for the factory were viewed.

The General Manager provided an update on the appointment of a new Health, Safety and Environment Manager for the site and also discussed the ongoing permit variation application.

The discharge point, W1 from the ETP to the River Dee was visited but could not be seen as the river levels were too high.
