4. Details of our assessment

I confirm receipt of report of EDM TEN Investigation for BW2201201 - Rear of Tir Einon, Llanelli Asset ID 52247, which we received on the 12th March 2024.

The Initial Report included the required proposal with timeframes for an investigation into

the operation of the overflow. I approve the proposal which you now need to act on in order to comply with Condition 3.1.2 (a)(ii) of the permit by investigating the reasons for the exceedance in accordance with the approved investigation proposals.

It is recognised that the initial investigations recommendations detailed in Section 4.3 of the report have proposed time scales of the end of July 2024 for CCTV and Alphas refurbishment and then the end of July 2025 for the asset modelling following flow monitoring with delays indicated due to availability of flow monitoring equipment due to the number of assets being monitored. We welcome any potential reduction in the timescales if equipment becomes available in the program of works.
