4. Details of our assessment

This Compliance Assessment Report follows an Operator Monitoring Assessment (OMA) audit for air, a hazardous waste audit and a site visit on 21st March 2024.

OMA Audit

All air emissions monitoring is carried out by suitably qualified MCERTS accredited external contractor. The sites management system of air emissions monitoring is of a high standard

The site achieved an overall score of 95% for the OMA audit for air. The following recommendations have been made in order to improve the overall score:

- SOP23 needs to reference SOP25 in order to escalate any issues with emission limits.
- SOP23 requires more detail for contingencies if SHE Manager was not available and appoint a deputy to oversee the emissions monitoring.
- Review with the monitoring contractor any improvements that could be made to the location of A1 monitoring point and test methods to bring it into compliance with EN15259.

Hazardous Waste Audit

The Sherwin Williams UK Limited facility at Deeside is a waste producer (cradle site) which manufactures packaging materials. The site does not accept wastes from other sites.

Consignment notes for 2023 were requested during the inspection. Hardcopies of consignment notes are filed in a well organised folder.

A site tour was provided to view the current waste storage facilities. All wastes are segregated depending on waste type. A suitable level of secondary containment is provided at waste storage areas.

A review has been undertaken of waste consignment notes. Multiple waste chapters are used on waste consignment notes, this is consequential to the different activities at the site. No issues with coding of waste have been noted.

Overall waste consignment notes have been completed to a good standard and most of the required information is provided within the documentation for each waste movement. It has been noted that in some cases where waste packaging for chemicals has been produced, the waste transfer note fails to describe what residual chemicals might be present within the containers, but hazard codes are provided. In other cases the packaging is given a hazardous waste code, but no descriptions of what is in the containers are provided.

Recommendation

The operator is advised that where residual chemicals are present on packaging, it should be disclosed on the waste consignment note and the relevant hazard codes should also be included.
