This CAR form has been issued as an update to **CAR_NRW0042298**. Although at the time of the site visit on 10th August 2023 there were no birds on-site and all production had ceased, concerns were raised about rubbish which was still on-site, and about general site security, both of which were highlighted in that CAR form.

Photos were sent to me on 8th September 23 show that the rubbish had been tidied up and removed off-site as requested.

You confirmed via email on 3rd October 2023 that a monthly inspection regime has been instigated to ensure that security will be maintained onsite.

Because of the above, I am happy that you are Compliant with your permit.
