3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

On the 19/03/2024 we carried out an inspection of Llanrhidian Pumping Station Emergency Overflow (EO) which is located at Llanrhidian Wastewater Treatment Works PS. It was dry at the time of the inspection but there had been rainfall in the morning and during the days before the inspection.

The flows coming into the PS were relatively low and rag free. There was no evidence of any recent emergency overflows either within the pumping station or in the receiving watercourse. We have not received any notifications of breakdowns at the pumping station during the last year. Any discharges from this overflow would be un-screened.

The monitoring installed at the Emergency Overflow indicates that this EO is operating in response to rainfall. In 2023 the Event Duration Monitor recorded 139 spills with 74 of them being significant (>50m³). There is no permit in place to discharge storm sewage from this overflow.

Guidance Note 021 Unpermitted Storm Overflows lays out the steps you need to take when you become aware that an emergency overflow is responsive to rainfall and operates as a storm overflow. Please be aware that we normally refuse permit applications for existing emergency overflows to operate as storm overflows when they were not originally

designed as storm overflows. I believe this to be the case at Llanrhidian.

Action: In accordance with Guidance Note 021 Unpermitted Storm Overflows Section 5, please notify us that the EO is operating in response to rainfall by the 26/07/2024 and then carry out the steps described in Section 5.

Discharging storm sewage from the Emergency Overflow at Llanrhidian PS is a breach of permit condition 4.1(a) Nature, which specifies that the discharge shall not occur other than in an emergency.

This breach is in contravention of Regulation 38 (2) of the Environmental Permitting (England and Wales) Regulations 2016 which states that it is an offence for a person to fail to comply with or to contravene an environmental permit condition.

This CAR contains a Warning for this breach.

Legal status of this report
