Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This is a permit variation EPR/DP3735NP/V004

This variation incorporates the changes requested by the operator to increase the maximum total quantity of waste to be accepted at the site for Anaerobic Digestion processing from 22,500 tonnes per year to 26,500 tonnes per year.

There are no other changes to the permit as a result of this variation.

The rest of the installation is to be operated as follows:

This permit allows the operator to carry out anaerobic digestion of wastes and the combustion of the resultant biogas. Permitted wastes are non-hazardous biodegradable wastes including those controlled by the Animal-By-Products Regulations (ABPR). Hazardous wastes are not permitted. The total permitted annual throughput is 26,500 tonnes a year.

Renewable energy will be generated using the resultant biogas through the combined heat and power engine (CHP) with the liquid and solid intended for recovery to agricultural land as a biofertiliser.

Uncontaminated discharges from site shall be collected from areas in connection with the storage and treatment of waste via the existing surface water system providing they have been tested and confirmed to be free of ammonia.

The schedules specify the changes made to the permit. Schedule 1 of the notice specifies the conditions that have been varied and Schedule 2 comprises a consolidated permit which reflects the changes being made.
