4. Details of our assessment

Forms Energy1, Performance1 and WaterUsage1 were received on 8th April 2024, more than two months past their due date of 31st January 2024. National Grid Energy Distribution (NGED) did not request an extension to the due date and so have been issued with a Cat4 non-compliance for failure to submit reports by the date specified in the permit.

The reports are accepted.

Water Usage 2023

Total water use was less than in 2022, but increased by more than 15% per unit output (puo).

Energy Use 2023

Electricity use was less than in 2022 and about the same puo.

The permitted activity does not use gas or oil.

Performance 2023

Waste received was more than 20% less than in 2022.

The permitted activity does not use raw materials, generate any residual waste nor any wastewater.

NGED are reminded that it is their responsibility to submit all required reports by the due date specified in the permit. Natural Resources Wales (NRW) may consider extending due dates, but only if the request is received before the due date.

In future, NGED should ensure that all reports are received by NRW on or before the due date.
