Site visit was arranged to enable a further review of Celsa's ongoing actions to control the flies in the scrap cans that are stored on site.

The weather conditions at the time of the visit were dry and sunny, temperature was approx. 20 degrees Celcius and there was a light wind. There had been some significant rain over the previous few days.

The scrap yard area was visited. All external piles of scrap tins had been consumed in the furnace. No scrap tins were now being stored externally. There was still a significant inventory (7181t as advised on 19th August 2019) stored under cover in the Old Meltshop building. There was no evidence of any fly activity associated with this stockpile.

Spraying was continuing on the remaining stockpiles at a current frequency of twice a week.

The fly traps that were on the northern boundary fenceline had been replaced earlier the same morning (current replacement frequency is weekly). There were only a small number of flies that had been caught in these and there were very few flies in the proximity of the traps.

Celsa still had an embargo on the importation of further scrap cans and NRW were keen for this to continue. It was noted that the pest control contractor that Celsa were using had advised the normal breeding season runs until the end of September.

Overall the measures Celsa had followed appeared to have been very effective.

NRW had not received any recent complaints related to flies in the local area.

NRW enforcement response remains under consideration.

RL was advised that the wind sock at the Mineral Site on Tide Fields Road was missing. Site operatives were therefore unable to make an informed assessment of the potential off site impact of any fugitive dust releases.
