4. Details of our assessment

A Water Resources compliance visit was carried out by Sioned Jones from the Dwyfor & Meirionnydd Environment Team on the 10th of April 2024. No issues were identified at the time of the visit.

SOURCE OF SUPPLY & POINT OF ABSTRACTION

The water is abstracted from a borehole at NGR SH 26444 36940 at Nyffryn, Dinas, Pwllheli.

No issues were identified.

MEANS OF ABSTRACTION

The water is abstracted from a 175ft deep borehole via a pump (figure 1). The diameter of the borehole was not measured during the visit as it was obstructed by the pump.

No issues were identified.

PURPOSE OF ABSTRACTION

All water abstracted is used for the purpose of agriculture, other than spray irrigation.

No issues were identified.

MAXIMUM QUANTITIES OF WATER TO BE ABSTRACTED & MEANS OF MEASUREMENT OF WATER ABSTRACTED

During the time of the visit, the licence holder noted that the water is currently used by approx. 350 cattle, 100 calves, and 13 adults.

The actual daily abstracted quantity (40.625 m³) at the time of the visit was compliant with the licence limit of 40.73 m³.
