### 4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales accompanied on site by operator Mark Wiberg of M&R Commercials.

The purpose of the visit was to assess compliance following the breaches identified during the previous inspection on 8th November 2023, detailed in CAR\_NRW0042793.

#### **General Management W1A- (previously C2, C4)**

The site previously scored a **category 3** breach of permit **condition 1.1.3** for failing to provide the Environmental Management System on request as required under the above condition.

Following on from the previous inspection the site were able to provide evidence that the EMS was available on request as required under **condition 1.1.3**.

Previously, undepolluted ELV's were stored on an impermeable surface resulting in a **category 2** breach of permit **condition 2.3.1**. The site was required to ensure that the waste was stored in line with the condition of the permit.

During the inspection it was noted all wastes were removed from the area of impermeable surface and stored on areas with concrete padding and sealed drainage.

#### **Technical Requirements W2F - (previously C4)**

During the previous inspection the site processed ELV's in a manner that did not allow for full depollution as required under **condition 2.5.1**. The site was required to follow the technical standards set out in **condition 2.5.1** and **table 2.5** of the permit to ensure correct depollution methods are used.

No evidence was identified during the inspection to indicate the site does not follow the technical requirements for depolluting vehicles under **condition 2.5.1**.

#### **Reporting W4B - (previously G4)**

The site is yet to provide NRW with the waste returns as required under **condition 4.2.2** of the permit. As identified previously the site has not submitted waste returns to NRW since 2015.

The site is required: *Within one month of the end of each year, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information*

*specified on the form relating to the site and the waste accepted and removed from it during the previous year.*

**This is an ongoing breach for condition 4.2.2.**

**Action - Ensure that waste returns are submitted as required under the above permit condition.**
