4. Details of our assessment

Natural Resources Wales senior industry and waste regulation officers Carter Shone and Phil Harper visited FMC Ltd on the 11th April 2024. This was a site inspection to review actions of the previous CAR (CAR_NRW0042944) accompanied by the EHS Manager.

General management

6 monthly checks of all site boundaries have now been added to the maintenance schedule.

Weekly checks are now being conducted by the site EHS dept of spills bins and are being recorded on a weekly spill bin form.

The site

Observation regarding the site's containment curbing were made during a previous site inspection on the 04/12/2023. An extract of corresponding Compliance assessment report (CAR_NRW0042944) is shown below:

'The curbing of the northeast perimeter line has become degraded. Especially in the corner adjacent to the storage of the ammonium nitrate, with a number of the curbing blocks having 1cm gaps between them.

This has resulted in a category 3 score against permit condition 3.2.1 under compliance criteria (IR3B) Emissions of substances not controlled by emission limits. The 'defective containment infrastructure' could potentially lead to a bypassing of the containment system causing pollution.'

On return to the site, officers have observed that the majority, including the worst affected area, of the northeast perimeter curbing had been sealed and testing has been conducted in order to ensure impermeability.

The work to complete the sealing of the remaining northeast containment curbing is still ongoing due to very wet weather but will need to be completed to fully satisfy the action.

Action: Ensure all of the northeastern curbing containment boundary is impermeable by 31/07/24.

No odours were noted during the inspection.

No offsite noise was noted during the inspection.

New nitric tank

The construction of the new nitric acid tank is now near completion with the tank, scrubber and bund all having been installed.

The operator has started the process of submitting a permit variation application.

The operator is reminded that the use of the new tank would be subject to a permit variation and can not be used until permit variation has been determined.
