4. Details of our assessment

On the 3rd April, Senior Environment Officer Cathrine Kiely and Environment Officer Nathan Owen met with the Sewerage Manager and Pollution Technician for DCWW as part of the pre-season bathing water checks at Colwyn Bay bathing beach. The weather at the time of visit was rainy.

The outfall for Beach Road CSO was inspected and there was no signs of sewage fungus or pollution. There was a discharge from the outfall however the bacti sample taken showed low bacterial levels (Ecoli 171, Intestinal Enterococci 270). Please confirm whether the discharge was storm overflow or infiltration.
