4. Details of our assessment

This was a pre-planned audit carried out by Natural Resources Wales Environment Officers on 05/03/2024 who were accompanied by a Senior Operative and Performance Manager from Dwr Cymru.

The weather was dry at the time of the visit with moderate rainfall the day before on 04/03/2024.

General Observations

The storm overflow being assessed in this CAR form is located at Carway Wastewater Treatment Works (WwTW) which was covered by a different permit at the time of the visit (BC0017801 01) and the site is covered in a separate CAR form. The permit for the storm overflow at the time of visit

was BP0361501 01).

The Process

Sewage effluent enters the works at the inlet. Effluent is then screened through a rota screen on the inlet channel, with a bar screen also available for use in another channel parallel to the inlet channel. The screenings are deposited into a wheelie bin for collection.



Figure 1: An image showing where storm effluent is separated from the inlet.

There is a storm overflow weir following screening in the inlet channel which diverts flow from the works during periods of heavy rainfall. Storm effluent is diverted to the bottom of the works into a chamber where further screening is provided by a bar screen. Effluent is then discharged to the receiving watercourse.
