## 4. Details of our assessment

This Compliance Assessment Report (CAR) follows the review of annual emissions monitoring data for Combined Heat and Power (CHP) unit NB1. The emissions monitoring was completed by an MCERTS accredited third party test house on 17/11/23. The emissions monitoring results were submitted to Natural Resources Wales (NRW) on 08/01/24 which is within the timescales specified in the permit.


All parameters recorded values within the permitted Emission Limit Values (ELVs):

Oxides of nitrogen (NO and NO<sub>2</sub> expressed as NO<sub>2</sub>) recorded a value of 174mg/Nm<sup>3</sup> versus an ELV of 475 mg/Nm<sup>3</sup>.

Dust (particulate matter) recorded a value of 23mg/Nm<sup>3</sup> versus an ELV of 50mg/Nm<sup>3</sup>.

Carbon Monoxide recorded a value of 21.3 mg/Nm<sup>3</sup> versus an ELV of 225 mg/Nm<sup>3</sup>.

TVOC recorded a value of 1.4mg/Nm<sup>3</sup> versus an ELV of 30mg/Nm<sup>3</sup>.
