## 4. Details of our assessment

This Compliance Assessment Report (CAR) follows a site inspection at Newbidge Energy Ltd on 10/01/24. This was an unannounced site inspection following a report of smoke from the site on 07/01/24.

Immediately before attending site, NRW staff carried out offsite observations in the vicinity of the Glasdir housing estate and the nearby Aldi car park. Both Combined Heat and Power (CHP) units were operational and emissions were visible from both stacks. No odours or smoke detected.

On arriving at site, NRW officers were met by the Health, Safety and Environmental Compliance Manager, who accompanied officers during the inspection.


All fuel for the CHP units was stored undercover within the fuel storage bunkers.

Results from recent moisture tests on the CHP fuel were reviewed- all were within the CHP manufacturer's specifications.

There were no odours or smoke detected on site.

Skips containing bottom ash/ fly ash were covered.

The operator stated that the CHP units were operating as expected, with no known issues. Emissions from the stacks were likely to be more visible due to lower temperatures.
