On 22 August 2018 a site inspection was carried out by Sally Wakeford and Ffion Thomas. We were accompanied on site by Shaun O'Kelly

A large area of pavement was showing signs of wear, however this was scheduled in for routine maintenance as soon as possible.

There was a large stockpile of wood waste, which had built up due to offtake issues. You are looking for suitable alternatives. I will remind you that Table 1.1 of your permit states the timeframes and amounts of wastes which can be stored on site at any one time.

There was a small amount of escaping litter at the side of the site, please ensure no litter escapes the site.

A very small amount of hardcore and plaster board was off the impermeable pavement. All wastes must be stored on the impermeable pavement with sealed drainage system.

With regards to the permit, NRW is required to review permits to ensure they are fit for purpose and to update permit requirements to modern conditions. Your permit is being considered for review.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
