4. Details of our assessment

Non-Compliance with Permit conditions 2.3.1.a (i) & Table 3.3 at St Nicholas Crescent CSO, Pembroke Rear 4, St Nicholas Crescent, Pembroke, Pembrokeshire,

SA71 4QG (Environmental Permit BP0065801) and associated pollution of the Pembroke Mill Pond

Following the report of a pollution event sighted on the public walkway alongside the Mill Pond at Pembroke town an NRW officer attended the scene on the afternoon of the 27/02/2024. The officer substantiated that sewage material had entered the watercourse from the St Nicholas Crescent CSO. NRW have completed their investigations into the matter and have identified the following offences:

Offence: Environmental Permitting Regulations 2016 Regulation 38 (2) –

‘Fail to comply with/contravene permit conditions 2.3.1.a (i) and Table 3.3’

Date: on or before 27 February 2024

Offence: Environmental Permitting Regulations 2016 Regulation 38 (1)(a) – Contravene regulation 12 (1).

‘Allowing polluting matter from a non-compliant combined sewer overflow discharge to enter a watercourse known as the Mill Pond’.

Date: On or before 27 February 2024

Important information

Legal status of this report
